LIMITED WARRANTY

10 (Ten) Year Non-Prorated Material Warranty Against Yellowing and 5 (Five) Year Non-Prorated Warranty Against Breakage Caused by Hail for PolyStrong™ PC Polycarbonate Panels

Kemlite Company, Inc. warrants the initial purchaser that, for a period of 10 (ten) years from the date of original purchase, PolyStrong sheets will not undergo a loss in light transmission in excess of 6 (six) percent in comparison with the original value when tested in accordance with ASTM D1003 (95); will not undergo a change in excess of 10 (ten) delta in comparison with the original value when tested in accordance with E313-73.

Kemlite also warrants for a period of 5 (five) years from the date of original purchase, PolyStrong Sheets will not break from hail damage, and will not lose their impact strength as described below.

Determination of loss of impact strength through weathering leading to hail breakage will be carried out by an impact test according to ASTM D5420-95 and D5628-95 method F geometry FA (tip diameter .624in). In the practice of this test the event is considered a failure when the upper wall of the sheet is penetrated by the tup. The sheet is not up to required standard if the Mean Failure Energy obtained in the test is less than 0.831 Joules. This energy is equal to the energy of an ice ball .787in in diameter with a speed of 69ft per second.

IF POLYSTRONG SHEETS DO NOT PERFORM AS STATED DURING THE WARRANTY PERIOD, KEMLITE COMPANY, INC. SHALL EITHER SUPPLY REPLACEMENT SHEETS OR, REFUND THE PURCHASE PRICE AT THEIR DISCRETION.

Kemlite Company, Inc. shall have no liability whatsoever for the cost of removal of defective sheets or the installation of replacement sheets and shall not be liable for any consequential or other loss, damage, misuses, improper storage, neglect or misapplication of the product.

This warranty is extended only to the original purchaser and is non-transferable.

Conditions:

This warranty applies only to PolyStrong Sheets which are treated, installed, cleaned and maintained according to manufacturer's recommendations. It is important to note that PolyStrong Sheets are protected on one side with a special weathering Ultra-Violet (UV) radiation prevention treatment. This protected side must be installed on the exterior side of the installation for this warranty to be in effect. No warranties are extended on the abrasion resistance characteristics of this product. No warranties are extended on the on the yellowing or loss of light transmission caused by dirt, scratches, breakage or other damage.

This warranty specifically excludes PolyStrong Sheets that have been formed or molded by vacuum or heat methods. This warranty applies only to PolyStrong Sheets.

Kemlite Company, Inc., or its accredited agent must be notified in writing of every claim within the warranty period and immediately after occurrence of the defect, enclosing the sales receipt and warranty. The claimant must certify that the conditions above have been fulfilled and must allow inspection at the installation site.

THE FOREGOING IS THE SOLE AND EXCLUSIVE WARRANTY APPLICABLE TO POLYSTRONG SHEET. ANY OTHER CLAIMS FOR DAMAGE OR LOSS EITHER DIRECT, INDIRECT OR CONSEQUENTIAL, WHATEVER THE CAUSE THEREOF, ARE EXPRESSLY EXCLUDED FROM THE WARRANTY. KEMLITE COMPANY, INC. WARRANTIES, EXPRESSED OR IMPLIED, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY FOR A PARTICULAR PURPOSE.
